
Nov/Dec Public Health Campaign: Hypertension

Working Group for Community Pharmacy

FMD Key Facts:

- All pharmacies will need appropriate equipment and software to comply with the FMD requirements from the 9th of February 2019 onwards.
- There are two main systems options i.e. "Integrated" with current pharmacy management systems or a "standalone" solution.
- Contractors will need to consider the operational impact on their dispensing processed from the FMD requirements when choosing between integrated and standalone systems.
- Medicines will start to arrive with an FMD compliant barcode and anti-tampering devices. These packs will need to be scanned through the FMD compliant system to "verify" the pack.
- These packs will also need to be scanned at the point of handover to the patient to "decommission" the pack.
- FMD will be regulated by the MHRA and compliance with the requirements is mandatory.
- Brexit will not delay the implementation of FMD on the 9th of February 2019.
- A "no deal" Brexit in March 2019 will result in the cessation of FMD requirements in the UK. A UK version of the FMD principles is likely to be introduced subsequently under these circumstances.
- Due to the uncertainty caused by Brexit it is recommended that contractors do not enter into long term contracts with suppliers of FMD compliant equipment and software.



Quality Payment Update

The review point for the second Quality Payments scheme 2018/19 is almost upon us - Friday 15th February 2019

To claim for a Quality Payment, contractors will need to complete a declaration via the NHS Business Services Authority (NHS BSA) website.

The declaration period, during which a payment can be claimed, will be between Monday 4th February 2019 at 9am and Friday 1st March 2019 at 11.59pm.

Once the declaration has been submitted, the contractor will receive an email from the NHS BSA confirming that their declaration has been successfully submitted and confirming the details that have been declared.

Flu Vaccine ordering for 2019/20

PHE has issued a joint letter with NHS England and the Department of Health and Social Care to provide guidance to pharmacies and GPs on ordering flu vaccines for the 2019/20 season.

This follows a review of the latest evidence on flu vaccines conducted by the Joint Committee on Vaccination and Immunisation (JCVI) and the issuing of advice on the most effective vaccines for the 2019/20 flu season.

The joint letter advises that both of the vaccines that were recommended for the 2018/19 season (QIV & ATV) will continue to be recommended for next year. Both vaccines are currently licensed and available

to order for use in the UK.

As in the 2018/19 season, standard trivalent vaccines (TIVe, previously known as TIV) are <u>not</u> to be used in any age or clinical at-risk group.

PHE also anticipates that two further products will be licensed for the 2019/20 flu season: a cell-based QIV, which will be suitable for use both in those aged 18 to 64 years and in those aged 65 years and over; and a high dose trivalent vaccine (TIV-HD) which will be suitable for those aged 65 years and over. Once licences are granted and list prices of the new vaccines have been agreed, NHS England will write

to pharmacies and GPs confirming the full recommendations for the 2019/20 flu programme.



What should you do now?

Read the joint letter and begin ordering currently licensed vaccines as set out in the letter.

For the new, currently unlicensed vaccines, please wait for confirmation from NHS England that they are eligible for reimbursement before ordering.

The EROY service is being updated, expressions of interest for which went out to contractors on 6th Nov 2018 with a closing date for submission of 23rd Nov 2018. New contracts will be issued to the selected pharmacies by NHS England in due course.

Finally remember to claim! If you don't claim you don't get paid...

Instructions:

All Claims should be made quarterly on PhamOutcomes.

The pharmacy will enter the service delivery information onto PO, there are stock check sheets to help you do this on our website.

Pharmacies can claim for their initial stock investment [Part A] or [Part A & Part B] as indicated in the SLA by completing a one-off 'claim for date expired stock' on PO.

If a medication expires you will need to replace it immediately 'Claim for date expired stock' on PO.

If you experience any stock problems during the life of

the service please report these on the relevant part A or part B PO platform using the 'Report OOS' section.

Don't forget to submit your completed Medicines Use Review (MUR) and/or New Medicine Service (NMS) data to the NHS Business Services Authority (NHS BSA) within 10 working days from the last day of December 2018.

The data will be publicised; therefore it is imperative that contractors submit their data on time.

Please Note:

The LPC recommends that pharmacies keep/print a copy of the confirmation email you receive when you submit your quarterly data to the NHS BSA, as evidence of submission.
