



LPC Governance Working Group

Terms of Reference

Purpose

The purpose of the Governance working group shall be to: assure the LPC's adherence to the LPC's governance framework and duties under the LPC constitution and rules; review the provisions of the LPC governance framework at specific intervals; promote and demonstrate good governance as part of the LPC's values; consider any complaints about an alleged breach of governance by any member or officer of the committee referred to the group by the main committee (subject to 3.1) in accordance with the provisions of the LPC model constitution, rules and the governance framework.

Membership

1.1 Governance lead and a minimum of two members of the main committee shall be appointed by the main committee.

1.2 In the event that a Governance working group member ceases to be a member of the LPC, is disqualified from being a member of the working group or resigns, a ballot shall take place to elect a new Governance working group member for the remaining duration of the governance task.

1.3 The members of the Governance working group may co-opt an additional member from members of the LPC, if it is necessary to ensure that the group includes representation of both the independent and multiple sectors.

1.4. The members of the working group shall appoint a chairman from amongst the members.

1.5 The Governance subcommittee members should not also be officers of the main committee.

Accountability

2.1 The Governance working group shall be accountable to the main committee.

2.2 The Governance working group shall determine the frequency of its meetings to discharge its duties. The working group may need to meet more frequently should a specific issue arise which needs further discussion and agreement.

2.3 The Governance working group shall report its discussions and outcomes to the main committee; if confidential information has been discussed by the Governance working group but cannot be immediately reported to the main committee, the Governance Lead shall inform the committee and provide the information when in is in a position to do so.

2.4 A Governance working group member with a conflict of interest should step down temporarily, in which case the working group shall co-opt an additional member from the main committee.

2.5 The working group, may invite the LPC Chief Officer or other officer to part or all of one or more of its meetings if their input is required to deal with a specific issue.

2.6 There is no quorum for the working group but the maximum attendance will be sought when arranging a meeting.

Actions

3.1 The Treasurer may refer directly to the Governance Lead any matter of governance relating to Committee members' expenses claims.

3.2 The subcommittee may require any LPC member to report directly to it.

3.3 Shall investigate all complaints or allegations made against members or officers of the committee referred to it by the main committee.

3.4 May, with the consent of the main committee, conduct an investigation into an alleged breach of governance, on behalf of another LPC, in accordance with the model LPC constitution.

3.5 Review the LPC's governance framework at least annually and assure the LPC's adherence to the framework and the governance provisions set out in the LPC constitution and rules.

3.6 The Governance Lead should be re-elected 2-yearly. This election should coincide with the election of the new Officers.
